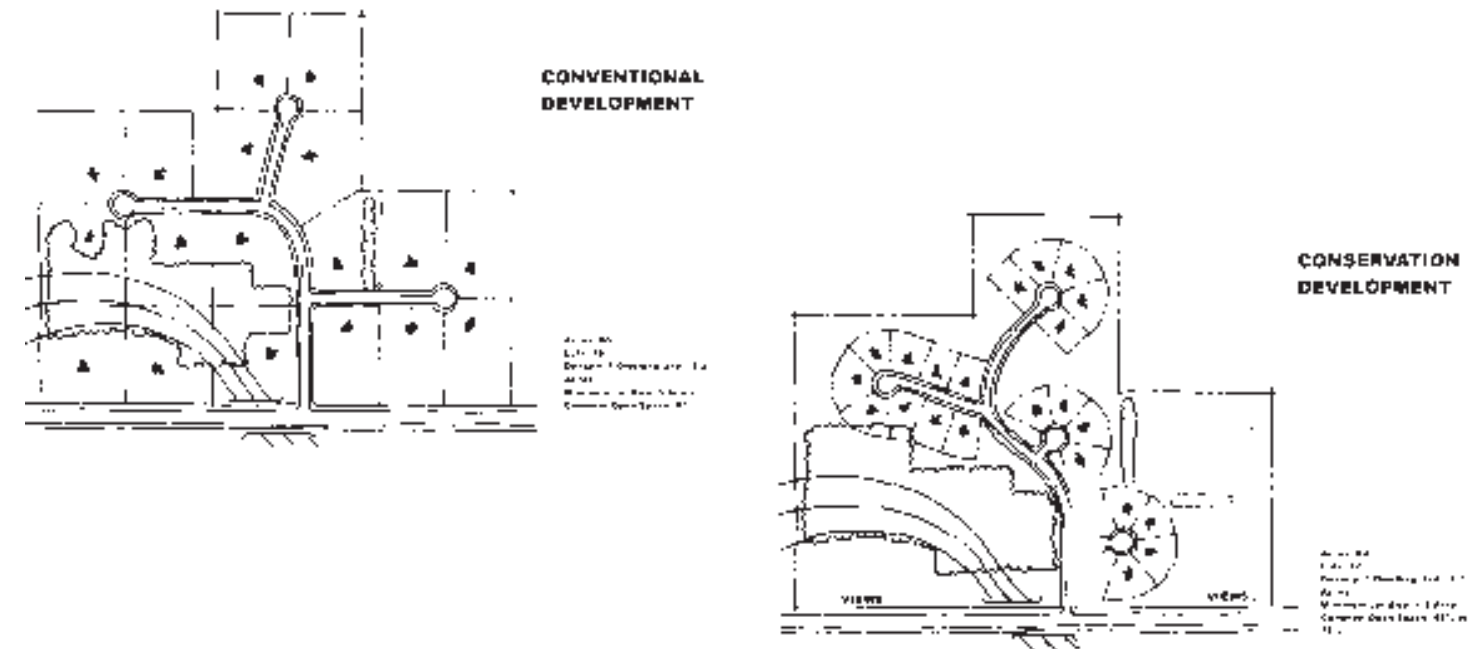
## Conservation Design Subdivisions - Proposed Ordinance Changes for Open Space Preservation

An average of 4,500 acres are converted to rural residential subdivisions in St. Croix County each year; that's nearly one township every 5 years! Much of this development occurs in the traditional manner that maximizes the number of lots on a property with little or no regard to the natural features present. The rural character important to so many of us is destroyed in the process.

A new, more sustainable option for residential development is the conservation design approach. Conservation design preserves rural character and natural resources by allowing smaller residential lots in exchange for open space preservation. Under the new ordinance, a developer is given a bonus in the number of lots he/she can create in exchange for setting aside at least 65 percent of the property in permanent open space. The open space can be farmland, lakeshore, river corridor, woodland, or other environmentally sensitive areas. The open space must be protected with a conservation easement and could be owned by an individual, a homeowners association, or it could be donated to the state or a nonprofit organization such as a land trust.

*Conservation design subdivisions allow smaller residential lots in exchange for preserving farmland or natural features on the landscape. Conservation design subdivisions will be possible in St. Croix County if the County Board approves the proposed Land Division Ordinance in December 2005.*
